

## Directions to Lakeland Village Golf Course

### From Olympia/ I-5 South

- ◆ Take ramp right for US-101 North/Pacific Coast Scenic Byway toward Port Angeles / Aberdeen
- ◆ Take ramp right for SR-3 North toward Bremerton / Shelton. Bear right onto SR-3/Olympic Hwy S Keep straight onto N 1st St. Turn right onto E Pine St. Keep straight onto SR-3 / E Pine St. Turn left onto E Lakeland Dr. Turn right onto E Old Ranch Rd. Turn right onto road. Last intersection is E Old Ranch Rd. Turn right on Old Ranch Road and continue to the Lakeland Village Pro Shop.

### From the Tacoma Narrows Bridge

- ◆ Continue west on SR16 for 20 miles to Gorst (approx. 20 min.).
- ◆ Take the southbound Highway 3 exit towards Belfair/Shelton, turning left at the stoplight. Go 12 miles (approx. 15 min.) to Allyn.
- ◆ Turn right on Lakeland Drive, go up the hill, past the clubhouse on the right and the lake on the left, to Old Ranch Road. Turn right on Old Ranch Road and continue to the Lakeland Village Pro Shop.

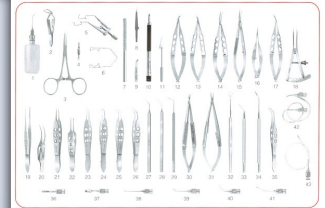
